System Worth Saving

On April 14 Post 6 at 7 p.m. will be hosting an informal town hall meeting on The American Legion's "A System Worth Saving". Legion to Congress

WASHINGTON (April 9, 2014) --The American Legion's national commander, Daniel M. Dellinger, told Congress at a hearing today that Department of Veterans Affairs (VA) leaders must be held accountable for mistakes that result in needless deaths at its medical facilities.

"Patient deaths are tragic -- preventable deaths are unacceptable," Dellinger told the House Committee on Veterans' Affairs. "But failure to disclose safety information -- or worse -- to cover up mistakes, is unforgivable, and The American Legion will not sit quietly by while some VA employees cover up the truth -- and the VA shouldn't, either." Dellinger recalled the deaths of six patients from an outbreak of Legionella

bacteria at the Pittsburgh VA medical center. When a team from the Legion's System Worth Saving (SWS) Task Force visited the facility last November, administrators claimed the outbreak was caused by equipment failure. E-mails and internal memos indicate human error, however. At the Atlanta VA Medical Center, Dellinger testified, "two veterans died of an overdose, and one committed suicide, that was attributed to mismanagement and an inability to get the mental health care they needed in a timely manner. Veteran suicides continue to plague our nation at 22 per day, with no clear strategy from VA on addressing suicides proactively." "We all need to continue to ask the hard questions," Dellinger told the committee. "What is VA doing to fix these problems, and are they concerned about keeping me informed? How is VA holding their leaders accountable for these errors?" "The American Legion will not stop asking the hard questions, and we hope you won't, either."

Phishing Scam

Phishing Activity Targeting Veterans/My HealthVet

This is to inform you of several reports that Veterans received an e-mail from a non-VA email account requesting that they click a link to confirm their interest in a secure exchange of medical records. These emails are NOT being generated by VA or My HealthVet. The message is designed to look like it came from My HealthVet so the Veteran will be tricked into clicking the link. My HealthVet and VHA Privacy and Security teams are aware of this issue and are working to inform Veterans and law enforcement about these events. Veterans should NOT open the message but NOT delete it until VA has a copy with the embedded links in the message. If you think you have one of these phishing messages, you can forward it to my e-mail address (James.Doherty@va.gov) and I will take it for action. If a Veteran or a family member reports that they clicked on the link of a "bogus" email, it is recommended they update and run their anti-virus, anti-malware, anti-spyware program and change their passwords.

Legacy Fund News

Last year the challenge for The American Legion Legacy Fund was met by a total of \$764,000 being raised. The Fund provides educational assistance to the child/children, or the legally adopted child/children, of active duty United States military, Guard and Reserve personnel who were federalized and died on active duty on or after September 11, 2001. Since 2004, more than 100 grants of educational assistance have been awarded, and the number of grant requests continues to grow each year as more and more children enter college. We do not want to turn any eligible child away. The American Legion Riders have organized and will execute the ninth annual American Legion Legacy Run and it is scheduled for August 17-21, starting in Indianapolis, IN, and ending in Charlotte, NC, site of this year’s 96th National Convention. The Riders will be leading the National Convention Parade in downtown Charlotte. All monies go directly into The American Legion Legacy Scholarship Fund. The National Commander’s goal is to raise \$400,000 for the Legacy Fund and in order to meet this goal your support is needed. Just a reminder of the free \$1,000 to the Legionnaire AD&D insurance available thru the LIT. Last year the program was expanded to cover up to \$5,000.00 free insurance IF you were travelling on official Legion business and were killed or had a dismemberment as a result of an accident. Official business would be travelling to or from a meeting either at the Post, District or Department (conference or convention). All the Legionnaire has to do is apply for it and is not automatic. I do not know of any family who could not use the additional funds at a time of necessity due to the loss of a loved one. In reviewing just what members of posts that are participating in the program, it is very eye opening that many, many members have not enrolled in this program.

Home Depot News

The Home Depot Foundation added \$3.9 million in grants to organizations across the country that address veterans' housing needs. The recent round of grants brings the Foundation's financial contributions to the issue of \$65.7 million since launching its mission in the spring of 2011 of ensuring every veteran has a safe place to call home. To date, donations made by The Home Depot Foundation have impacted more than 10,200 units of veterans' housing. Some of the project funding included:

- \$1.7 million to nonprofits to repair or construct 323 units of permanent supportive housing for veterans, including 225 units that serve veterans with families.
- \$800,000 to nonprofits that will provide transitional housing to 131 homeless veterans.
- \$400,000 to a nonprofit organization that offers 58 women veterans and their families a permanent supportive housing solution.
- \$875,000 to provide critical home repairs and maintenance to 126 single-family homes owned by veterans and their families.
