National Commander Response

The following is the National Commander's response to President Obama's announcement recently.

"The American Legion applauds President Obama for committing himself to hold leadership at the Department of Veterans Affairs more accountable for their actions. If this system-wide failure is to be corrected, it is paramount for our commander-in-chief to be personally involved. The president needs to ensure that every veteran who relies on the VA can do so secure in the knowledge that he or she will receive the best and most timely care humanly possible. "The question is this: if the administration has known about these issues for at least four years, why is it just now taking action? "Moreover, the president's decision to keep Secretary Shinseki at his post is an unfortunate one. The VA has been aware for some time that inappropriate scheduling procedures are widespread among its medical facilities. Yet Secretary Shinseki has taken no initiative in correcting the problem. Veterans continue to die waiting for their health care, senior VA executives continue to get their bonuses, and only after all of this is the secretary now pledging to fix what's wrong.

"So now America's veterans are told, in effect, wait a while longer and things will get better. Meanwhile, care is delayed or denied and veterans and their families suffer. Words are nice, and even somewhat comforting, but when will the VA's house be cleansed of those who are soiling it and dishonoring the system?"

MIAP Internment

The Missing in America Project (MIAP) with assistance from Legionnaires from American Legion Post 71 North Augusta, SC, and Post 193 of Chapin, SC, will conduct a full military honors funeral service for seven previously unclaimed Veterans at 1:30 p.m. on 6 June 2014, at the Fort Jackson National Cemetery in Columbia, SC. This will be the seventh ceremony held in South Carolina since Governor Haley signed an Act in May 2012 TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, by adding CHAPTER 12 TO TITLE 25, which authorized Veteran Service Organizations to receive from funeral homes and coroners the unclaimed cremated remains of Veterans and have them interred at National Cemeteries beside their Brothers and Sisters in Arms. The Veterans being interred have collectively served our Country for more than 23 years. Six of these heroes served in the United States Army and one served in the United States Navy. They served during World War II, the Vietnam War and the Cold War. Little more is known about these Veterans other than

the fact that they honorably and faithfully served their Country. When these men left the world, they had no one to claim them and to ensure that they received the proper dignified burial they earned and rightfully deserved. Members of the Missing in America Project, members of the American Legion, Patriot Guard Riders and other Veteran Service Organizations from South Carolina, will make sure that these heroes are buried with dignity, honor and respect. This interment is being supported by Veterans and community members from across the State of South Carolina the Kornegay & Moseley Funeral Home is providing the MIAP with a hearse and staff to transport the cremated remains of these heroes and Juveniles from the SC Department of Juvenile Justice are building the urns and will also attend the service.

The cremated remains of these seven Veterans will be escorted from Chapin American Legion Post 193, 102 Lexington Ave. Chapin, SC 29036 at 12:40 p.m. Friday, June 6, 2014 by members of the Missing in America Project, as well as American Legion Riders of South Carolina and the Patriot Guard. The funeral procession will travel to the Fort Jackson National Cemetery for the ceremony which will begin at 1:30 p.m.

Chaplain Emeritus Tom Fincher will officiate the ceremony, an Honor Guard from Fort Gordon Georgia, American Legion Post 71 and the U.S. Navy will provide Full Military Honors. The public is invited to attend the ceremony to honor our American Heroes.

Patriots Point Naval & Maritime Museum is hosting a not-to-be-missed symposium on June 6th, commemorating the 70th Anniversary of D-Day and our USS LAFFEY veterans. The USS LAFFEY, docked at Patriots Point, is **one of only two** Naval warships left in existence that were at the Invasion of Normandy. Two of the LAFFEY's veterans who were there on that historic day in World War II history are joining us. This symposium will include first person accounts of the invasion that resulted in the destruction of Nazi Germany. Video and music will enhance the event on board the USS YORKTOWN.

Pro Bono Info

Lawyers4Vets - Monthly Pro Bono Veterans Legal Clinic

Introduction: As a service to area Veterans, the South Carolina Appleseed Legal Justice Center has partnered with the Wm. Jennings Bryan Dorn VA Medical Center and members of the private bar to establish Lawyers 4 Vets, a Pro Bono Veterans Legal Clinic.

Purpose:

Lawyers 4 Vets connects low income and homeless Veterans with attorneys who provide legal advice and representation on certain issues.

Legal Issues and Services: The clinic will ONLY address the following topics:

- Obtaining identification (Social Security, South Carolina State ID, birth certificates)
- Child support and visitation issues (in South Carolina)
- Expungements and pardons (for convictions from South Carolina courts)
- Consumer protection
- Simple wills and healthcare power of attorney

Eligibility:

Veterans will be screened for eligibility, and if eligible will be given an appointment at the clinic. Lawyers 4 Vets will assist eligible Veterans regardless of military discharge status.

Appointments: Veterans who would like to be screened for eligibility should call the number listed below and leave a message including their name, phone number, and legal issue. The Veteran will be contacted within 2 business days by an intake volunteer who will ask the veteran a number of questions to determine if they are eligible. If the Veteran is eligible and has a qualifying legal issue, they will be given the next available appointment at the legal clinic. Appointments are required for a Veteran to receive a face-to-face meeting with a lawyer. Walk-ins will not be seen and will be directed to contact the telephone intake.

Defensive Driving Course

Rehab Services will be offering an eight-hour Defensive Driving course to all eligible veterans on 5/30/14 at the Dorn VA Medical Center in Columbia. The course may be good for a four-point reduction from one's driver record. The course will last from 8:00 a.m. to 5:00 p.m. and there is **NO CHARGE** for the course. (Similar courses in the community range in cost from \$55-\$85). To be eligible the veteran must be enrolled at the Dorn VA Medical Center. If the enrollment is at the Charleston VA Medical Center, the veteran should contact Alan Simmerson, RKT, at 803-776-4000, ext. 7052. The veterans must also be in possession of a valid South Carolina driver's license. Some car insurance companies allow for a 5-10% decrease in premiums if the insured has completed this course.

Home Depot News

The Home Depot Foundation added \$3.9 million in grants to organizations across the country that address veterans' housing needs. The recent round of grants brings the Foundation's financial contributions to the issue of \$65.7 million since launching its mission in the spring of 2011 of ensuring every veteran has a safe place to call home. To date, donations made by The Home Depot Foundation have impacted more than 10,200 units of veterans' housing. Some of the project funding included:

- \$1.7 million to nonprofits to repair or construct 323 units of permanent supportive housing for veterans, including 225 units that serve veterans with families.
- \$800,000 to nonprofits that will provide transitional housing to 131 homeless veterans.
- \$400,000 to a nonprofit organization that offers 58 women veterans and their families a permanent supportive housing solution.
- \$875,000 to provide critical home repairs and maintenance to 126 single-family homes owned by veterans and their families.
