Child Welfare Foundation News

The American Legion Child Welfare Foundation, in its 60th year, has awarded \$566,691 to 18 non-profit organizations. These grants, determined during the annual meeting of the Board of Directors, held at the Sheraton Hotel City Centre in Indianapolis, Indiana, on Sunday, October 12, 2014, have been awarded to support youth-serving projects that seek to enhance the lives of children by addressing the physical, mental, emotional and spiritual needs of children. The following is a brief summary of the grants awarded for 2015. *Angel Flight West* of Santa Monica, California, was awarded \$10,000 for their project, "Promoting Fly-Anthropy – the charitable use of aviation to help children in need." This grant will provide outreach and marketing efforts to reach families in need of medical transportation and to potential volunteer pilots. *Beads of Courage, Inc.* of Tucson, Arizona, was awarded \$40,000 for their project, "Beads of Courage." This grant will fund the purchase of beads to encourage ill children as part of the Beads of Courage program. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant.

*Birth Defect Research for Children* (dba Association of Birth Defect Children) of Orlando, Florida, was awarded \$22,650 for their project, "National Outreach for Birth Defect Prevention." This grant will help redesign the organizational website and advertise available resources to families and medical professionals. The American Legion Auxiliary sponsors this grant.

*Children's Cardiomyopathy Foundation* of Tenafly, New Jersey, was awarded \$25,400 for their project, "7 minute video to answer genetic testing questions as it relates to Pediatric Cardiomyopathy." This grant will fund the production of a video to be distributed via electronic newsletter and online to reach interested families and physicians. The American Legion Auxiliary sponsors this grant.

Children's Craniofacial Association of Dallas, Texas, was awarded \$10,000 for their project, 'Wonder-Choose Kind.' This grant will provide educators with resources to teach children anti-bullying and kind behavior towards those afflicted with craniofacial issues. The American Legion Auxiliary sponsors this grant.

Children's Institute, Inc. of Rochester, New York, was awarded \$7,580 for their project, "Strengthening Military Family Relationships Through Play." This grant will underwrite the production and dissemination of instructional DVDs to educate Boys and Girls Club staff on the needs of military children. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant.

*Children's Organ Transplant Association* of Bloomington, Indiana, was awarded \$43,595 for their project, "The American Hometown Heroes for COTA Campaign." This grant will fund an informational campaign that will connect Reserve and National Guard COTA families to Legion posts that support COTA. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant.

*CureSearch for Children's Cancer* of Bethesda, Maryland, was awarded \$31,500 for their project entitled, "CureSearch 2014 Educational Video Series." This grant will produce and distribute videos on staying healthy while on chemotherapy, eating healthy and information on clinical procedures such as biopsy and ultrasound. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant.

*Diabetes Education & Camping Association* of Florence, Alabama, was awarded \$39,640 for their project, "Optimizing Outcomes at Diabetes Camp – Integrated HER System." This grant will fund a mobile application and software for health data management. The American Legion Auxiliary sponsors this grant.

*JAYC Foundation, Inc.* of Santa Rosa, California, was awarded \$50,540 for their project, "Creating Protected Spaces." This grant will provide comprehensive education between families, mental health professionals and law enforcement agencies through booklets and videos.

*Marfan Foundation* of Port Washington, New York, was awarded \$30,000 for their project "Parent's Toolkit: Your Child and Marfan Syndrome." This grant will provide informational toolkits for parents of children with Marfan Syndrome. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant. *Mercy Flight Southeast* of Leesburg, Florida, was awarded \$21,761 for their project, "Project Outreach SE USA 2014." This grant will fund a marketing campaign to advertise medical transportation services offered by the organization for public awareness and pilot recruitment.

*Mercy Medical Angels* of Virginia Beach, Virginia, was awarded \$44,000 for their project, "Child Health Program – Info Dissemination Upgrade." This grant will update and disseminate information on the organization's child health program. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant.

*National Autism Association* of Attleboro Falls, Massachusetts, was awarded \$58,075 for their project, "Big Red Safety Box Program." This grant will enable the continuation of the Big Red Safety Box program that addresses dangerous wandering incidents. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant.

Our Military Kids of McLean, Virginia, was awarded \$31,350 for their project, "Our Mission Continues: Moving into the Next Decade of Supporting Our Kids." This grant will enhance outreach and marketing efforts of the organization. The American Legion Auxiliary and The Sons of The American Legion sponsor this grant. Spina Bifida Association of Arlington, Virginia, was awarded \$25,000 for their project, "Educating Children with Spina Bifida on Staying Healthy." This grant will underwrite the printing of "Another Way to Go," a publication that teaches children about catheter care. The American Legion Auxiliary sponsors this grant. The American Legion of Indianapolis, Indiana, was awarded \$55,500 for their project, "2015 American Legion National Youth Programs Scholarships." This grant will provide academic scholarships to the top youth participants of the organization's national youth programs. The American Legion Auxiliary sponsors this grant. United States Association of Blind Athletes of Colorado Springs, Colorado, was awarded \$20,000 for their project, "USABA Mobile Coach." This grant will expand the number of sports offered on Mobile Coach to assist blind youth athletes compete. The Sons of The American Legion sponsor this grant.

#### **New VA Regulation**

On September 23, the Department of Veterans Affairs (VA) published its final regulations and fact sheet related to the Camp Lejeune historical drinking water contamination as required by law. VA announced the publication of two regulations: one providing health care for Camp Lejeune Veterans, and the other reimbursing for health care expenses of their family members potentially affected by contaminated drinking water at United States

Marine Corps Base Camp Lejeune, North Carolina. The regulations implement provisions of the "Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012."

The first regulation, entitled Hospital Care and Medical Services for Camp Lejeune Veterans (A078), took effect immediately. The second -- Payment or Reimbursement for Certain Medical Expenses for Camp Lejeune Family Members (AO79) – will take effect in 30 days. The published regulations now allow VA to reimburse eligible Camp Lejeune family members for out-of-pocket health care costs related to any of the 15 covered medical conditions listed in the 2012 Act. Under that law, VA can reimburse costs from March 26, 2013, onwards. Family members can start applying 30 days after the regulation publication date. For information Camp Lejeune including eligibility about VA's program, apply, http://www.publichealth.va.gov/exposures/camp-lejeune or call 1-877-222-8387. Since the passage of law, VA has enrolled and provided health care to those Veterans who served on active duty at Camp Lejeune for at least 30 days between January 1, 1957 and December 31, 1987.

#### **Background:**

President Obama signed the *Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012* into law on August 6, 2012. In compliance with the law VA provides healthcare for those Veterans who meet the criteria for health care. From 1957 to 1987, people living or working at Camp Lejeune were potentially exposed to drinking water contaminated with chemicals known as volatile compounds, including industrial solvents and benzene from fuels.

The law provides that Veterans stationed at Camp Lejeune between 1957 and 1987 will be eligible to receive health care through VA, and exposed family members will be reimbursed for health care costs, for the following medical conditions:

Esophageal cancer; Lung cancer; Breast cancer; Bladder cancer; Kidney cancer; Leukemia; Multiple myeloma; Myelodysplastic syndromes; Renal toxicity; Hepatitis steatosis; Female infertility; Miscarriage; Scleroderma; Neurobehavioral effects; and Non-Hodgkin's lymphoma. For family members, VA will be the last payer and will provide reimbursement after all other health insurance coverage and reimbursement is received, as required by law.

Frequently Asked Questions:

#### Q: Who is eligible for the Camp Lejeune program?

**A:** Veterans may be eligible for Camp Lejeune coverage if they meet the following criteria:

- Served on active duty at Camp Lejeune for no less than 30 days between January 1, 1957 and December 31, 1987, and
- Meet all the qualifications for VA benefits, including meeting the VA definition of "Veteran," and receiving a discharge other than dishonorable. Additional qualifications can be determined by completing the 10-10EZ form and enrolling in VA benefits.

Family members may be eligible for the program if they resided on Camp Lejeune as a dependent of an Active Duty Servicemember, or were in *utero*, for no less than 30 days between January 1, 1957 and December 31, 1987, and have one of the illnesses or conditions listed in the law. VA may reimburse costs associated with hospital care and medical services, as the last payer, for the eligible family members for the 15 illnesses or conditions. Once those family members have submitted claims to their insurance companies, they can apply to VA for reimbursement of the remaining balance of charges and fees connected to the qualifying illnesses.

## Q: How do Veterans and family members apply for the Camp Lejeune program?

**A:** For Veterans: Veterans seeking to enroll in VA health benefits can enroll online at <a href="https://www.va.gov/healthbenefits/apply">www.va.gov/healthbenefits/apply</a> or at their local VA Health facility (<a href="https://www.va.gov/directory">www.va.gov/directory</a>). Veterans seeking more information about VA's Camp Lejeune Program or to apply via phone can call 1–877–222–VETS (8387). Veterans should locate relevant documentation to show proof of Camp Lejeune residency of not less than 30 days (e.g., copies of orders, base housing records, medical or school records, etc.). This information will be utilized by the Veteran Health Administration to validate eligibility for care under this authority.

**For family members**: Once the family member regulation is effective, interested family members will be able to apply online. Submitted applications and supporting documentation will be reviewed to determine family member eligibility for the program. Once deemed eligible for the program, family members who have received

care for one of the 15 Camp Lejeune conditions since March 26, 2013, can submit a claim for reimbursement. Family members should keep receipts for medical expenses related to the covered illnesses/conditions. Because the Camp Lejeune law only reimburses expenses, as the payer of last resort, related to the 15 conditions, family members should not change their existing health insurance. Family members who have questions regarding applying for Camp Lejeune Family Member Program benefits, claims payment, appeals, or other related matters should call toll-free 1-866-372-1144 between the hours of 7 am and 4:30 pm CST.

#### O: Is the reimbursement for care retroactive?

**A:** No, reimbursement is only from the point in time the Veteran enrolls in VA, if after 8/6/12 or reimbursement of VA copayments back to 8/6/12, if already enrolled and identified as a Camp Lejeune member within 2 years of publication of the rule. VA began providing Veteran care for Camp Lejeune on 8/6/12, following the passage of the "Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012".

### Q: Does this law provide Veterans with disability compensation?

**A:** No. This law allows Camp Lejeune Veterans to enroll in VA health care. It does not provide service connection and compensation. Veterans who believe they have an injury/illness related to their military service may file a claim for disability for their condition at their Department of Veterans Affairs Regional Office.

#### **Veterans Preference**

The federal government's veterans preference policy has been criticized in report released last August by the Merit Systems Protection Board (MSPB), which suggested that such preference causes resentment among civilian federal workers, and decreases the number of women being hired into the federal work force. The Washington Post and Government Executive have reported on MSPB's findings without challenging the conclusions. "We've seen the report and its claim that veterans preference for federal jobs is creating resentment among federal workers who are civilians," said Michael D. Helm, national commander of The American Legion, "and the claim that it interferes with the hiring of women. "To any civilian workers who have problems with veterans preference, The American Legion's message is simple: Become a veteran. Those who have served in uniform have earned such preference." Helm also took issue with MSPB's finding that veterans preference had a negative impact on the hiring of women. "The federal government has been hiring fewer people in general since fiscal 2011 – that includes women. But the good news is that more women veterans, and more veterans in general are being hired." Noting that the percentage of women employees in the federal work force has dropped only one percent since 2000, Helm said veterans preference needed to remain in place to help veterans compete with civilians in the job market. "We understand that some individuals abuse the policy, and that needs to be corrected. But helping those who have served in uniform get jobs, especially those who are disabled, is a policy that must remain in place." Mark Reinhold, associate director for the Office of Personnel Management, wrote in a letter that "OPM does not concur in your somewhat negative assessment," and that MSPB "seems really to be taking aim at the entire civil service system in its current form." Helm said The American Legion will closely monitor any suggested changes to veterans preference policy. "We urge the Office of Personnel Management – and Congress -- to continue supporting our veterans in the federal job market with its hiring policies."
