## The American Legion Nathan M. Wolfe Law Enforcement Cadet Academy.

The Law Cadet Academy is held in June of every year (since 1973) at the SC Criminal Justice Academy in Columbia SC. The intent of the camp is to give high school students, who are potentially interested in a law enforcement career, a better working knowledge this field emphasizing the everyday demands of an Officer. The staff and counselors are members of various law enforcement agencies to include the SC Highway Patrol, SLED, Dept. of Natural Resources (game wardens), Dept. of Corrections, Military Police, Police/Public Safety and Sheriff's office. The students will be immersed into a period of instruction and hands on training utilizing law enforcement facilities and equipment. The goal is to insure that each student leaves with a better knowledge and appreciation of Law Enforcement in South Carolina.

## The American Legion Palmetto Boys State

Boys State has been a program of the South Carolina American Legion since 1940 and is considered the most respected educational program of government instruction for high school students. At Boys State, students are exposed to the rights and privileges, the duties and the responsibilities of a franchised citizen with each participant becoming a part of the operation of his local, county and state government. The training is objective and practical with city, county and state governments operated by the students elected to the various offices. Activities include legislative sessions, court proceedings, law enforcement presentations, assemblies with visiting dignitaries, bands, chorus and recreational programs. 2014 Boys State will again be conducted in the month of June at Anderson University.

This past summer, with the assistance of generous donors (see reverse for listing), we were fortunate to send 3 high school students to Boys State and 2 students to Law Cadet Academy.
